



Community Grants Program Guidelines

(Updated December 2020)

This financial year, council's Community Grants Program is bolstered by the temporary addition of COVID-19 Community Response Grants, temporary changes to co-funding requirements in Major Grants, and increased and expanded Emergency Grants.

Recognising that demand for grant funding is increasing, and in light of the disruptions COVID-19 has caused our community, council will continue to offer grants as a strategic investment tool, which is responsive to community's changing needs.

Focus will remain on supporting projects which:

- *respond to community need and deliver on council's priorities*
- *activate the community in a resilient and vibrant way*
- *inject money into the local economy*
- *are ready to get started and be successfully completed*
- *deliver maximum community benefit.*

The Community Grants Program supports projects that contribute to the delivery of council's corporate priorities as informed by our long term strategic policy positions on community, economic development and environment. The Program aims to acknowledge and strengthen the valuable contribution that community groups and their volunteers make towards achieving our shared vision and goal of being *Australia's most sustainable region: healthy, smart, creative* and fostering a *strong community*.

In line with the endorsement of council's Sunshine Coast Community Strategy 2019-2041, we welcome applications that contribute towards the following strategy outcomes:

- *Healthy and active communities* - Empower our community to live healthy and active lifestyles.
- *Vibrant communities* - Focus on ensuring community places and spaces are vibrant, inclusive, accessible, adaptable and meet the needs of people of all ages, abilities and backgrounds.
- *Inclusive communities* - Strengthen connection, inclusion, awareness and opportunity for all people in our community.
- *Connected and resilient communities* - Build capacity in our communities to be connected, resilient and to respond to local issues.
- *Creative and innovative communities* - Nurture creative and innovative approaches to building a strong community.

* Co-funding requirements have been temporarily suspended for amounts between \$7500 and \$10,000. Co-funding requirements apply for requests over \$10,000. Requests over \$15,000 must be for infrastructure projects.

Major and Minor Grants

Major and Minor Grants support community organisations to deliver one-off projects, events and activities that align with council's strategic priorities and demonstrate a community purpose.

Eligibility Criteria

Who can apply?

Not-for-profit community organisations that meet all of the following:

- operate within the Sunshine Coast local government area or can demonstrate the project or program will benefit residents of the Sunshine Coast local government area
- have appropriate insurance and adhere to sound workplace health and safety practices
- are able to demonstrate viability
- have no debt to council, or have entered into scheduled payment arrangements with council, which are being met
- have met acquittal conditions for previous council grants.

If a community organisation is not a legal not-for-profit entity or recognised by the Australian Taxation Office as a not-for-profit type, the application must be auspiced and administered by such a group.

Applicants requesting over \$5000 are encouraged to discuss their application with a council Grants Officer prior to submission.

Applicants may submit only one grant application per round.

Who cannot apply?

Applications cannot be made by:

- government agencies or departments of local, state or federal government
- educational, religious or medical organisations, where the application is for the organisation's core business
- businesses
- individuals.

Projects eligible for funding

To be eligible for funding, applications must:

- demonstrate a purpose that is in the public interest, with significant community need and benefit
- demonstrate strong alignment with council's priorities as described in current council strategies, plans or policy positions
- adhere to the terms and conditions of this funding program.

Projects not eligible for funding

- Ongoing operational or recurrent costs including salaries, rent, fuel
- Activities that have already begun prior to a grant application being submitted
- The core business of educational, religious or medical organisations
- Prize money, prizes or trophies
- Development of privately-owned facilities
- Payment of debt
- Political activities
- Projects run solely for commercial profit
- Items included in another council grant application
- Projects run solely for fundraising purposes, without broader community benefit.

Higher and Lower Priority

Higher priority

Higher priority is given to projects that:

- increase the self-sufficiency of community organisations
- reduce environmental impact and/or provide energy, water and waste efficiencies
- build skills, capacity and governance of community groups
- demonstrate collaboration and partnerships
- activate places and spaces.

Higher priority is given to applications that demonstrate evidence of:

- procuring from local businesses, social enterprises and/or First Nations (Aboriginal or Torres Strait Islander) businesses
- budgeting to procure a Welcome to Country by the Traditional Owners of the Sunshine Coast (the Kabi Kabi or Jinibara people)
- committing to sound environmental practices

If successful, you will be asked to include evidence of meeting relevant high priority areas in your acquittal.

Lower priority

Lower priority is given to:

- applicants who have been awarded a council Major or Minor grant within the previous 12 months
- projects or events that have previously been awarded a council Major or Minor grant.

What Funding is available?

Minor Grants

Apply for up to \$2000 to fund community projects.

Major Grants

Apply for up to:

- \$30,000 to fund infrastructure projects – see Community Facilities category
- \$15,000 to fund one-off projects, events and activities – see all categories

Co-funding

Council cannot be the sole funder of every project. Depending on the amount requested, funds from other sources may be required. Other funding sources could include:

- applicant cash contributions
- grants from other funding bodies
- sponsorship
- in-kind support.

Co-funding requirements have been temporarily amended in this program. The table below outlines co-funding requirements applicable to March 2021 Major Grant round:

Amount requested from council	Minimum co-funding requirement
Up to \$10,000	No requirement
\$10,001 - \$30,000	50% of total project costs from other sources

*Eg To be eligible for \$30,000, the total cost of the project would be at least \$60,000.
NB Up to 20% of the co-funding requirement can be volunteer hours, valued at no more than \$43.30p/h.*

Assessment Criteria

Major and minor grant applications will be assessed using the following criteria:

- need for the project/activity
- alignment to program intent and the specific purpose and priorities of the chosen category
- strength of alignment with council's corporate priorities as described in current council strategies, plans or policies
- consideration of higher and lower priority projects and applications
- evidence the organisation is working towards or maintaining self-sufficiency
- benefit to the people of the Sunshine Coast local government area
- evidence of consultation and community partnerships and collaboration
- capacity of the applicant to successfully complete the project
- balanced, realistic and complete project budget
- evidence that the organisation has inclusive participation policies and practices
- level of funding contributed by the applicant and/or others towards the project.

Categories

Applications for major and minor grants must align to the specific category purpose and meet one or more of the relevant priorities in one of the following categories:

- *Community Development*
- *Community Events*
- *Community Facilities*
- *Cultural Development*
- *Cultural Heritage*
- *Economic Development*
- *Sport, Recreation and Healthy Living.*

Each of these categories delivers on one or more Sunshine Coast Community Strategy 2019-41 outcome/s.

Community Development

Outcomes: Healthy, Active Communities; Inclusive Communities; Connected, Resilient Communities

Projects and activities that respond to an identified local need and build more inclusive, engaged and safer communities.

Category priorities (address one or more):

- young people (aged 12-24)
- positive ageing
- health and wellbeing
- Traditional Owners (Kabi Kabi and Jinibara people), and local Aboriginal and Torres Strait Islander peoples
- multicultural communities
- access and inclusion
- community safety
- animal management

Projects funded under this category will:

- promote social inclusion
- enhance cultural awareness and embrace diversity
- encourage healthy eating and the availability of fresh, healthy foods
- foster partnerships and collaboration between community groups
- enhance community safety
- encourage community engagement, participation and volunteerism
- engage with the community to encourage a sustainable Sunshine Coast.

In relation to applications for animal management grants, projects must:

- enhance community safety outcomes
- align with the key objectives of council's Domestic Animal Management Strategy 2014-2020
- assist in the promotion and advancement of responsible pet ownership practices eg desexing, microchipping, registration.



Community Events

Outcomes: Connected, Resilient Communities; Creative, Innovative Communities

Projects that support sustainable community and regional events and celebrations that reflect cultural values, diversity and the lifestyle of our communities.

Category priorities (address one or more):

- promote a vibrant, diverse and fun place to live and visit
- support and build capacity of local event management talent and suppliers
- demonstrate sound event management principles and planning
- contribute to local economy by planning events which attract a broad range of patrons and participants
- contribute to building strong communities - inclusive, connected, engaged, healthy and active
- demonstrate a commitment to the development of local creative skills and cultural pursuits
- increase access and engagement with cultural heritage, including Aboriginal and Torres Strait Islander traditional and contemporary cultures
- demonstrate a commitment to sound environmental practices and the promotion and protection of our natural environment
- celebrate and contribute to our lifestyle, environment and culture.

Ineligible Items

The following are not eligible:

- school and church fetes
- celebration or competition activities and events where attendance is limited to individual organisations or their members
- judging or adjudication fees
- uniforms
- purchase of catering, hospitality, food and beverages
- purchase of merchandise, trophies and prizes.

Lower priority

Christmas events scheduled to take place in the same suburb or within the catchment area (5km radius) of the five council-sponsored community Christmas carol events will be a lower priority.

Note: To be eligible for funding in this category, events must be scheduled to take place after notification of funding outcomes.

Applicants new to this category must discuss their project with a council Events Officer prior to submitting their application. Please contact the Grants Team on (07) 5420 8616.

Community Facilities

Outcome: Vibrant Communities

Infrastructure projects that involve the development, maintenance or improvement of buildings or land that contribute to providing a safe, accessible and inclusive community facility.

This category supports facilities that contribute to the development of one or more of the following:

- a positive sense of community
- a creative and artistic region
- healthy communities and active lifestyles
- safe communities
- nature-based recreation infrastructure.



Category priorities (must address all):

- provide well maintained and accessible community facilities which enable opportunities for social interaction
- adhere to the principles of access and equity
- address issues of risk management or compliance with Australian Standards
- have a current maintenance schedule.

In relation to applications for nature-based recreation infrastructure projects only, applicants must discuss the project with council's Recreation Trails Activation Officer prior to submission.

Note: Organisations with formal council tenure are required to complete any works required under their leasing arrangements prior to being funded for other projects.

Cultural Development

Outcome: Inclusive Communities; Creative, Innovative Communities

Projects that strengthen the creative ecology of the Sunshine Coast by nurturing connections, promoting experimentation and inspiring collaboration.

Category priorities (address one or more):

- build local creative skills and capacity
- increase local participation in arts and creative activities
- provide creative opportunities that engage with diverse segments of the community
- position creative experiences in unexpected places and spaces
- demonstrate collaboration between industry sectors or include strong partnerships
- foster opportunities for Traditional Owners (Kabi Kabi and Jinibara people), and local Aboriginal and Torres Strait Islander artists.

Cultural Heritage

Outcome: Creative, Innovative Communities

Projects that document, conserve, promote and make accessible the region's heritage and social history.

Category priorities (address one or more):

- provide opportunities to identify, document and preserve the history of settlement on the Sunshine Coast
- protect, preserve and celebrate the culture and heritage of Traditional Owners (Kabi Kabi and Jinibara people), and local Aboriginal and Torres Strait Islander people
- protect, preserve and celebrate the culture and heritage of Descendants of Australian South Sea Islanders
- provide access to, interpret and protect the unique lifestyle, places and landscapes within the Sunshine Coast local government area
- support contemporary heritage (post-1950s), including coastal heritage
- tell stories relating to the regional contribution to the war effort, industry and innovation
- encourage collaboration with other heritage organisations, to raise awareness and knowledge of regional cultural heritage
- incorporate innovative practices to conserve, educate and promote regional heritage, including conservation of significant objects
- have lasting community benefit.

Note: Applicants must discuss their project with a council Cultural Heritage Officer prior to submitting their application. Please contact the Grants Team on (07) 5420 8616.

Economic Development

Outcome: Strong economic leadership collaboration and identity; Creative, Innovative Communities

Projects that encourage and support local community organisations to contribute positively to improve the economic performance and prosperity of their local community.

Category priorities (address one or more):

- foster strong economic leadership and collaboration by government, business and industry
- encourage best practice in securing investment in the region's infrastructure priorities
- facilitate development of the region's high value industries including promotion of innovation, research and digital participation
- business projects focussed specifically on developing local to global connections and investment in talent and skills in the region's high value industries

Sport, Recreation and Healthy Living

Outcome: Healthy, Active Communities

Projects and programs that promote community participation in sport and recreational pursuits across the Sunshine Coast local government area.

Category priorities (address one or more):

- contribute to building healthy and active communities
- provide physical activity initiatives or opportunities
- improve the sustainability of sport and recreation clubs
- engage a broad spectrum of the community
- provide access for all abilities
- provide benefit to multiple user groups.

Emergency Grants

Eligibility criteria for emergency grants are the same as major and minor grants, except during a declared Disaster Situation*, where operational costs may be eligible for funding in this program.

Applicants can apply for up to \$3,000 to fund projects that have arisen as a consequence of failure, damage or loss of essential equipment or infrastructure due to unforeseen circumstances. During a declared Disaster Situation, applicants can apply for up to \$3,000 for other costs (including, but not limited to, operational costs when an organisation demonstrates financial hardship).

Funding must be for projects or costs which are:

- deemed to be an 'emergency' (requiring rapid response)
- significantly impacting the organisation's ability to continue to operate.

Note: Costs may be incurred prior to application, but applicants should be aware that funding is competitive, and council cannot guarantee that the application will be successful.

Costs that are covered by insurance are not eligible for Emergency Grant funding.

Only one Emergency Grant related to a declared Disaster Situation can be made by an organisation per disaster event, per financial year.

**A declared Disaster Situation, is one where a Notice of Declaration of Disaster Situation has been published in the Queensland Government Gazette, and affects the Sunshine Coast Local Government Area.*

Assessment Criteria

Emergency grant applications will be assessed using the following criteria:

- failure, damage or loss of essential equipment or infrastructure due to unforeseen circumstances and deemed to be an emergency
- significant impact on the organisation's ability to continue to operate
- significant health and safety implications for the organisation's and/or service users
- evidence that the project is not covered by insurance.

During a declared Disaster Situation the following assessment criteria can apply, subject to available budget:

- significant impact on the organisation's ability to continue to operate, due to:
 - costs that have arisen due to a declared disaster event, or
 - cash flow hardship as a result of a declared disaster event.
- costs meet the significant community need created by the declared disaster.
- priority will be given to applications which evidence an organisation's financial hardship and/or a plan for sourcing more sustainable funding into the future.

Individual Development Grants

Up to \$500 is available to support Sunshine Coast local government area residents who are performing, competing or presenting at national or international competitions, conferences or events (eg sport, arts, cultural, community, heritage, economic and environment).

Groups or teams attending the same event can apply for a group total of up to \$2000.

Individuals must be selected by a recognised national body and provide a letter of selection.

Funding will assist with expenses incurred whilst attending an activity eg travel, accommodation, entry fee and registration.

Who can apply?

Individuals who meet all of the following criteria:

- have been a permanent resident in the Sunshine Coast local government area for at least the preceding 12 months
- are representing the region by performing, competing or presenting at national or international competitions, conferences or events
- have met acquittal conditions for previous council funding.

In addition to the above, applicants for sporting events must be:

- competing in official national and international championships, recognised by a National Sporting Organisation (NSO) that is endorsed by the Australian Sports Commission
- selected for an official Queensland or Australian team, endorsed by the relevant National Sporting Organisation (NSO).

For non-sporting applications, the assessment panel will confirm the status of the selecting body.

Note: Activities that have already begun prior to a grant application being submitted are not eligible for Individual Development Grant funding.

COVID-19 Community Response Grants

Sunshine Coast Council's COVID-19 Community Response Grants are a temporary additional grant type within the existing Community Grants Program. For full guidelines for this grant type please see Council's website at www.sunshinecoast.qld.gov.au/grants.

Information for Grant Applicants

Application

Application forms for Major, Minor, Emergency and Individual Development Grants are available on council's website and must be submitted online.

Quotes are required for all items over \$500 and must be included with your application.

The delivery of the Community Grants Program is subject to annual budget allocations.

Assessment

Grants are assessed by panels, which include council staff experienced in each category.

In some instances part-funding may be offered.

Panel recommendations for Major, Minor, Individual Development and Emergency grants are reported to the CEO or delegate for endorsement. Panel recommendations for Major grants are provided to the Mayor and all Councillors for information only.

Payment

Grants program funds must be claimed within three months of notification, except where an extension has been granted.

If the applicant is being auspiced, payment will be made to the auspicing organisation.

Acknowledgement

As a condition of funding, successful applicants are required to actively and publicly acknowledge council's support. The level of acknowledgement is determined by the amount funded and outlined in the funding program agreement.

In addition, funding recipients must also ensure that council's positive reputation is maintained at all times.

Acquittal

All grant money must be acquitted within eight weeks of project completion.

Organisations will not be considered for further grant funding from council if previous grant acquittal conditions have not been met.

Applicant Support

Grants Officers can help community groups develop their project and applications, if required.
